Dear Parents and Guardians,

You may already be aware that due to matters out of the control of the police and the school, the judge in the trial relating to the incident that took place at the school in April of this year has determined that a retrial is needed.

The trial is set to be rescheduled to begin 27 January 2025. I appreciate this is not ideal however I wish to reassure you all that whilst we wait for this to take place it will be very much business as usual for pupils and staff at Ysgol Dyffryn Aman.

We accept that a substantial amount of information has been disclosed by the media on this trial during the last couple of weeks. We would like to therefore remind people that the teenager accused cannot be named for legal reasons. We urge people not to speculate on the details of the case, nor to share footage or material which could prejudice the case or cause further distress to those involved. Doing so could result in individuals being in contempt of court.

I again would like to reiterate that during this time we will continue to offer wellbeing support at the school to any pupil who requires our help.

We as a school, as we have been doing during this difficult time, continue to show maturity and kindness while we await the retrial.
